All Shots and neuter/spaying will be done and animal must be spayed or neutered within 90 days of transfer unless a veterinarian deems that the health of the animal may be in jeopardy and they require the animal to be older before surgery. Adoption fee of \$100 includes spay/neuter, 3 distemper shots and rabies shot. Amigo Animal Clinic at 586 25 Rd, Grand Junction, CO, 970 245-0210 can be contacted for the spay/neuter and rabies shot.

I hereby understand and agree that the Loma Cat House makes no representations or warranties, expressed or implied, about the mentioned animal's temperament and is hereby absolved from any liability for future damages or injuries caused by said animal. I also understand and agree that the Loma Cat House further gives no guarantees, expressed or implied, of the suitability of the animal to the foster and/or their family. Foster understands that cats cannot be tested for several diseases like ringworm, infectious peritonitis, etc. Loma Cat House cannot be held responsible for undetected disease.

I certify that all statements made by me on this adoption agreement are true and correct. I agree that the current owner has the right to confiscate the above described animal in the event that any statements made by me are found to be false and/or my check for the adoption fee is returned for insufficient funds.
